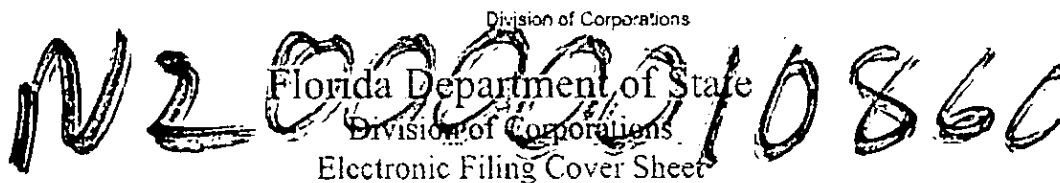





The Oikos Foundation's objective is to design, prepare and implement social benefit programs with priority to the most vulnerable and most at-risk population in order to contribute to the objective of achieving a world without hunger and zero poverty, for which proposes to intervene with projects aimed at reducing infant mortality by serving the population of children between 0 and six years old, as well as pregnant and lactating mothers through health, food and educational projects aimed at training mothers in order to contribute to the adequate performance of her maternal role.

The execution of projects aimed at improving the quality of life of family groups living in extreme poverty is also contemplated through programs aimed at the construction of low-cost affordable housing.

The Foundation also intends to promote the creation of jobs through educational farms for young people and adolescents who live in rural areas and have dropped out of formal education in the interest of teaching them a trade and promoting food production as a way of create jobs and reduce hunger and poverty. Likewise, the opening and start-up of ecological homes for poor elderly people that, in addition to providing them with a habitable, healthy and safe space, can serve as a distraction area by carrying out horticultural activities to cultivate part of their own food in an organic and healthy way.

In the educational area, the Oikos Foundation is committed to helping the general population to create awareness about the importance of protecting the environment, for which it will promote and disseminate audiovisual didactic campaigns aimed at the protection and preservation of the species that cohabit in the nature as a contribution to the maintenance of Planet Earth.

The Oikos Foundation also has a special interest in intervening with projects of social benefit to favor indigenous ethnic groups and intends to carry out these programs in the countries of Latin America and the Caribbean, especially in Venezuela.

In case of dissolution or closing of the corporation (FUNDACION OIKOS INC) all the assets of said Corporation will be transferred to the various organizations that the corporation have worked with in the past and present so they may continue the program(s) set forth in this Article.
