



IX. Prohibited Activities: No part of the net earnings of "Yeshua Spirit of Prophecy Ministries, Inc." shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3. No substantial part of the activities of "Yeshua Spirit of Prophecy Ministries, Inc." shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, "Yeshua Spirit of Prophecy Ministries, Inc." shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

X. Dissolution: In the case of the dissolution of "Yeshua Spirit of Prophecy Ministries, Inc.", after paying or making provisions for the payment of all the legal liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501c3 of the internal revenue code or the corresponding section of any future federal tax code or shall be distributed to the federal government, or to Florida or Palm Beach county government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.
