Re: Immediate notification, correction, and legal reinstatement of the following Corporation: St. Phard Family Foundation, Inc. (N20000011236) and EIN: (85-3421370).

This is in contrast to the current filing on March 30, 2024, by an unauthorized individual, Christopher St. Pard, who intentionally committed his fraudulent actions, as against our corp.

The corporation was mistakenly altered by this person, a resident of West Palm Beach: ST. PHARD FAMILY FOUNDATION, INC. Port St Lucie, FL (bisprofiles com). While we reside in Miami-Dade County, for over since 1982, and never lived, worked, or acquired and educational accreditation in WPB, FL, nor know anyone there, either. He used a name similar to our family name, but not spelled exactly as ours, instead using the abbreviated version as listed by the organization. This action, which almost mirrors his last name to our family members and the corporation's board members, is typically not allowed by the Florida Department of Corporations until the corporation is over two years old, as per the norms we understand.

Our family has faced severe illnesses and several deaths, which prevented us from updating our organization earlier this year. However, when we attempted to do so this week, before the end of September's compliance deadline with the state, we encountered this alarming and unjust situation caused by Mr. St. Phard.

As the original founder, President, and CEO of our corporation, I would appreciate immediate state intervention to provide advice and corrective relief. We are health professionals, and the individual who recently reinstated our organization and changed our EIN has a history of incarceration for using or trafficking unprescribed drugs. We do not wish our family's reputable professional name and organizational status to be associated with such individuals, who have a history of criminal activity and disregard for state laws, as demonstrated by their actions with our organization, misleading the state and reinstating our organization without considering future consequences or potential disciplinary actions from the judicial system and the state Department of Professional Regulations.

We appeal for assistance in correcting these disgraceful actions, hoping the state will agree to immediately and correctly reinstate our organization with its

submitted to the IRS and the state of Florida. We aim to move forward as intended, to save lives and help those in need.
