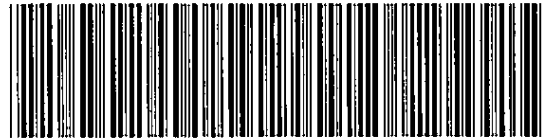

**Articles of Incorporation  
of  
Prolific Women, Inc.**

The undersigned incorporator, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

**Article I.** The name of the corporation is Prolific Women, Inc.

**Article II.** The principal address is 21001 San Simeon Way, Apt. # 209, Miami, Florida 33179. The mailing address of the principal office is the same as the street address.

**Article III.** Prolific Women, Inc. is a nonprofit organization that aims to produce influential and empowered women. Through educational programs, events and volunteer opportunities, young women will grow and develop as leaders to accomplish their goals.

**Article IV.** The corporation is organized and operated exclusively for charitable purposes in accordance with Section 501(c)(3) of the Internal Revenue Code.

**Article V.** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code.

**Article VI.** Upon the dissolution of the corporation, assets remaining after the payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and has tax exempt status under section 501(c)(3) of the Internal Revenue Code.

**Article VII.** The manner in which Directors are elected or appointed is as provided for in the bylaws.
