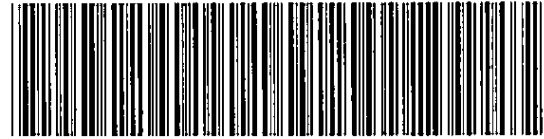

## ARTICLES OF INCORPORATION

### ARTICLE I NAME

#### 1.01 Name

The name of this corporation shall be God's Next Generation, Inc. The business of the corporation may be conducted as God's Next Generation or God's Next Generation, Inc.

### ARTICLE II DURATION

#### 2.01 Duration

The period of duration of the corporation is perpetual.

### ARTICLE III PURPOSE

#### 3.01 Purpose

God's Next Generation Inc. is a non-profit corporation and shall be operated exclusively for charitable, educational and developmental purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future Federal tax code.

The purpose of God's Next Generation is to offer educational programs to help and support underserved individuals and families struck by financial calamities. Our projects and programs are implemented with concrete and measurable outcomes.

Our projects and programs include educating curious and keen young children, and providing important technical and vocational skill-sets needed to help the financially impoverished change the future course of their lives.

## **GOD'S NEXT GENERATION INC.**

God's Next Generation is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its developmental, educational and charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

### **4.02 Personal Liability**

No officer or director of this corporation shall be personally liable for the debts or obligations of God's Next Generation of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

### **4.03 Dissolution**

Upon termination or dissolution of God's Next Generation, any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the 1986 Internal Revenue Code (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

The organization to receive the assets of the God's Next Generation hereunder shall be selected in the discretion of a majority of the managing body of the corporation, and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against the God's Next Generation, by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose, which, at least generally, includes a purpose similar to the God's Next Generation, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida to be added to the general fund.

### **4.03 Prohibited Distributions**
