In accordance with Chapter 617.0202, Florida Statutes, the undersigned natural person of the age of 21 years or more hereby files these Articles of Incorporation to form a notfor-profit corporation under the laws of the State of Florida.

#### <u>ARTICLE I</u>

#### NAME

#### <u>ARTICLE III</u>

#### **PURPOSE**

In furtherance of its exempt purposes, the corporation may promote, establish, conduct and maintain activities on its own behalf and it may contribute to or otherwise assist other corporations, organizations and institutions carrying on exempt activities.

#### ARTICLE IV

#### **POWERS**

The corporation hereby incorporates by reference any and all corporate powers given to corporations not for profit by virtue of Section 617.021 of the Florida Statutes. The corporation's activities are limited by the provisions of Section 617.0105 of the Florida Statutes which are incorporated by reference herein and any and all other restrictions which are required to obtain tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or any successor thereto).

#### ARTICLE V

#### TERM OF EXISTENCE

The corporation is to exist perpetually.
