ARTICLE I

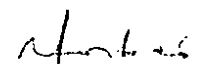

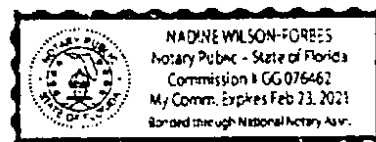
