The undersigned incorporator being competent to contract, subscribe to these articles of Incorporation to form a corporation not-for-profit under the laws of the state of Florida.

ARTICLE I-NAME

ARTICLE III- PURPOSE

A. The Corporation is organized exclusively for educational and charitable purposes, including, for such purposes, the making of distributions in organizations that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code of 1986, and more specifically to receive and administer funds for such charitable and educational purposes all for the public by bequest, devise, gift, purchase or lease, either absolutely or in trust for such objects and purposes or any or any of them, and property, real, personal or mixed without limitations, if any as may be imposed by law; to sell, convey, and dispose of any such property and to invest and reinvest the principal thereof and to deal with and expend the income therefrom for any of the before-mentioned purposes, without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received. The purpose of engaging in any activity or business permitted under the laws of the United States and of the state of Florida and shall have all of the powers enumerated in the Florida Not For Profit Corporation Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law. In general, to exercise and all and every power for which a non-profit corporation organized under the applicable provisions of the law of Florida for scientific, educational and charitable purposes all for the public welfare.

B. More specifically, the Corporation is for public policy purposes to advocate issues, platforms, policies and legislations that seek to preserve the principles of the United States Constitution and ensure that republican form of government prevails in the United States.

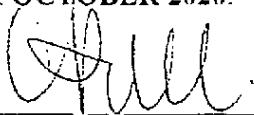

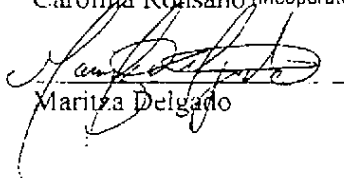
