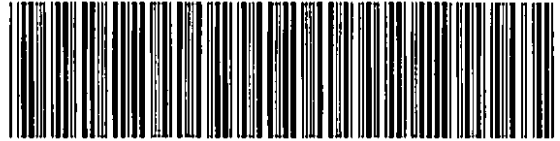

**ARTICLES OF INCORPORATION
OF
IGLESIA BAUTISTA FE Y ESPERANZA, INC.**

ARTICLE I:

The name of this corporation shall be: *Iglesia Bautista Fe y Esperanza, Inc.*

ARTICLE II:

The principal place of business of the corporation is: 357 Andalusia Loop., Davenport, FL 33837. The mailing address of the corporation is *P. O. Box 138148, Clermont, FL 34713*.

ARTICLE III:

The purpose of the corporation will be to promote the Kingdom of God. This will be done in corporate worship, by public testimony, by the proclamation of the gospel of our Lord Jesus Christ with **love, integrity, passion, justice and compassion**, by projects of mission service, through a Christian Education program that affirms all creation and children of God, by promoting our Christian faith, by defending justice for all, and in serving and helping the poor as ourselves with physical and spiritual needs.




