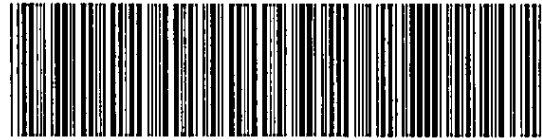

Article VIII This Corporation will focus its efforts and resources on carrying out its exempt activities for public benefit. The Corporation and persons acting on its behalf shall not take any action or carry on any activities that are prohibited for non-profit charitable organizations or for organizations to which tax-deductible contributions can be made.

Article IX No part of the Corporation's net earnings may benefit any disqualified person as defined by the Internal Revenue Service for exempt charitable organizations, except for reasonable compensation paid for services rendered. Upon voluntary or involuntary dissolution or winding up of the Corporation's affairs, after all debts have been satisfied, the remaining assets shall be distributed for exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or shall be distributed to a federal, state, or local government for a public purpose.
