# ARTICLES OF INCORPORATION OF FEEDING FRIENDS FOUNDATION, INC.

The undersigned incorporator, being competent to contract, subscribes to these Articles of Incorporation to form a corporation not-for-profit under the laws of the State of Florida.

## ARTICLE I - Name

The name of the Corporation shall be FEEDING FRIENDS FOUNDATION, INC. (the "Corporation").

#### ARTICLE II - Principal Office and Mailing Address

The address of the principal office and the mailing address of the Corporation is 1946 NE 201 St., Miami, FL 33179.

## ARTICLE III - Purpose

- The Corporation will be operated exclusively for charitable, scientific, educational, or literary purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue law) (the "Code"). The principal purpose of the Corporation (the "Purpose") is to provide, primarily through gifts to other Section 501(c)(3) organizations, food and other living assistance to poor and deserving N families.
- B. The Corporation is organized for purposes of engaging in any activity or business permitted under the laws of the United States and of the State of Florida and shall have all of the powers enumerated in the Florida Not For Profit Corporation Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law. However, the Corporation shall not engage in any activity in which corporations qualified as exempt organizations under Section 501(c)(3) of the Code are not permitted to engage.
- C. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, the Corporation's directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

- D. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by (i) a corporation exempt from federal income tax under Section 501(c)(3) of the Code, or (ii) a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.
- E. If the Corporation is classified as a private foundation under Section 509 of the Code, the Corporation (i) shall distribute its income each taxable year at such time and in such manner as not to subject itself to tax under Section 4942 of the Code, and (ii) shall not engage in any act of self-dealing (as defined in Section 4941(d) of the Code), retain any excess business holdings (as defined in Section 4943(c) of the Code), make any investments in such manner as to subject itself to tax under Section 4944 of the Code, or make any taxable expenditures (as defined in Section 4945(d) of the Code).

## ARTICLE IV - Term of Existence

The effective date upon which the Corporation shall come into existence shall be the date of filing of these Articles, and it shall exist perpetually thereafter unless dissolved according to law.

## ARTICLE V - Initial Registered Office and Agent

The street address of the initial registered office of the Corporation is 1946 NE 201 Street, Miami, FL 33179, and the name of the initial registered agent of the Corporation at that address is Rick Mars, DDS.

#### ARTICLE VI - Directors

- The method of election of directors shall be stated in the Bylaws of the Corporation. A. The initial number of directors of the Corporation shall be three (3).
- The number of directors may be either increased or diminished from time to time by the Board of Directors in accordance with the Bylaws of the Corporation, but there shall always be at least three (3) directors.
  - C. Directors shall receive no compensation for their services.

D. Directors shall be elected, appointed, and removed as provided in the Bylaws of the Corporation.

## ARTICLE VIII - Amendment to Articles

These Articles of Incorporation may be amended in the manner provided by law.

## **ARTICLE IX - Bylaws**

The power to alter, amend or repeal the Bylaws of the Corporation shall be vested in the Board of Directors, but subject to the approval of the Board of Directors of the Parent.

## **ARTICLE X - Dissolution**

A. Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all of its current liabilities, dispose of its remaining assets by distributing them in a manner that is not inconsistent with the purposes of the Corporation, and which will meet the requirements of Section 501(c)(3) of the Code.



B. Any assets not disposed of by the Board of Directors as provided herein shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the Corporation is then located, exclusively for tax-exempt purposes or to such organizations, which are organized and operated exclusively for tax-exempt purposes and which qualify as an exempt organization under Section 501(c)(3) of the Code.
