<u>Article I Name</u>

The name of the corporation shall be: Jonathan Adam Space Education Foundation, Inc.

Article II Principal Office

The principal street address is 1760 N. Jog Road #150, West Palm Beach, FL 33411 The principal mailing address is 1760 N. Jog Road #150, West Palm Beach, FL 33411

Article III Purpose

The corporation is organized exclusively for charitable, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

With a primary focus on education, the Jonathan Adam Space Education Foundation, Inc., is dedicated to fostering research, development, education and study relating to space travel and exploration.

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
