Attachment to Articles of Incorporation form for Chabad Chai Center Article III Purpose

This corporation is founded exclusively for charitable religious purposes within the meaning of the IRS Code Sec 501(c)(3); namely: To establish and maintain a Synagogue, a House of Chabad Chasidic Orthodox Jewish worship for the Jewish community in Boca Raton FL and elsewhere. This Synagogue will be a place to love, learn and live Judaism, at each person's own pace and at comfort level. The community so established will be close-knit, accepting and non-judgmental, and will be entirely composed of local families from diverse backgrounds and varying levels of practice, who have a strong commitment and pride in Judaism and the Jewish people. It will teach classical Judaism, and share knowledge of Torah, traditions and Jewish practice that are thousands of years old. It will be established on the belief that Jewish knowledge and practice connect us to G-d, give us our strength as a people, and provide the secret to a wonderful happy life, strong family values, and robust Jewish continuity.

The synagogue will have no membership requirement other than the sincere desire to grow in Jewish practice. Everyone is invited to come, partake and enjoy Jewish life, both holidays and year-round, through worship services, classes, spiritual guidance, community outreach, inspirational events, celebrations, sacred feasts, cultural or social activities and joyous holiday celebrations. The synagogue will likewise implement all manner of helpful services to the Jewish community and the general community. It will strive to bring all persons in the general community closer to The Creator in the ways that are right for each. It will carry out its activities according to Torah-Halachic tradition contained in the Code of Jewish Law (Shulchan Aruch) by Rabbis Yosef Karo and Moshe Isserles as well as in the Code of Jewish Law by Rabbi Shneur Zalman of Liadi and the Chabad guide to liturgy Sefer Haminhagim, all as understood by the synagogue's Rabbi and incorporator, Aaron Gopin.

This corporation will be empowered to pay salaries or wages, as well as to rent or buy personal or real property, in order to carry out its activities and provide a place of worship as well as a parsonage for Rabbi Gopin and his family. The Rabbi has been appointed by the community according to Jewish Religious Law. He is the spiritual head of the organization and the final authority in all matters pertaining to Ethics, Spirituality and Religious Law, including the sole right to determine

which questions or issues should be regarded as matters of Ethics, Spirituality and Religious Law, thus requiring his decision.

This corporation shall not, except in an insubstantial way, engage in any activities or exercise any powers that are not in furtherance of its charitable religious purposes. It will not attempt to influence legislation in any way or participate in political campaigns of any sort. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its directors, officers or any private person except that this corporation will be empowered to pay reasonable compensation for services rendered, to reimburse for expenses related to the carrying out of duties and make purchases of goods or services that are in furtherance of its exempt purposes.

This corporation is empowered to supply all the foods, religious items, constructions, items or properties required according to Chabad Orthodox Jewish Law, including --but not limited to-- Religious Articles, Kosher Food, Ritual Immersion Pools, or transportation to any event or location which in the view of the Rabbi or Directors is required for the fulfillment of Religious Duties as understood in Jewish and/or Chabad Chasidic Tradition. Upon the dissolution of the organization, its remaining assets shall be distributed for one or more organizations with similar exempt purposes recognized under section 501(c) (3) of the IRS Code.
