DOES HEREBY CERTIFY THAT:

- FIRST: The name of the Corporation is "Palm Garden Lakes Townhome Community Association, Inc."
- SECOND: The Corporation's Articles of Incorporation were filed on November 4, 2020.
- THIRD: The document number of the Corporation is N20000012438.
- FOURTH: The Board of Directors of the Corporation and the sole Member of the Corporation have determined that it is in the best interest of the Corporation to dissolve the Corporation.
