

**ARTICLES OF INCORPORATION  
OF  
WHOSOEVER WILL PENTECOSTAL APOSTLIC CHURCH, INC.,  
A FLORIDA NON-PROFIT CORPORATION**

**ARTICLE ONE. NAME**

The name of the corporation is THE WHOSOEVER WILL PENTECOSTAL APOSTLIC CHURCH, INC.

**ARTICLE TWO. STATEMENT OF CORPORATE NATURE**

This is a nonprofit corporation organized solely for general charitable purposes pursuant to the Florida Corporation Not for Profit Law set forth in Part I of Chapter 617 of the Florida Statutes.

**ARTICLE THREE. GENERAL AND SPECIFIC PURPOSES**

The specific and primary purposes for which this corporation is organized are the following:

- a. To engage in and transact any lawful business for which corporations be incorporated under the Florida Not for Profit Corporation Act. No other purpose limits this general purpose in any way; and
- b. To do such other things as are incidental to the purposes of the corporation or necessary or desirable to accomplish them; and
- c. To foster and promote the worship of God and to bring the word of God closer to its members.

#### **ARTICLE FIVE. MEMBERSHIP**

The corporation shall have a membership distinct from the board of directors. The corporation shall be organized upon a non-stock basis and the qualifications for membership will be as follows:

Any person desiring to become a member of the corporation shall apply for such membership to the Board of Directors and shall profess his or her belief in God and their desire to participate in the worship of God. Upon such application being made, the Board of Directors shall accept the applicant as a member of the corporation and register such membership upon the registration books of the corporation. All individuals who are members of The Whosoever Will Pentecostal Apostolic Church, Incorporated, and registered as such on the date of incorporation herein, shall be admitted to membership of the corporation without further act.

#### **ARTICLE SEVEN. LOCATION OF PRINCIPAL OFFICER IDENTIFICATION OF REGISTERED AGENT**

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

#### **ARTICLE ELEVEN. DISTRIBUTION OF ASSETS**

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws .

#### **ARTICLE TWELVE. AMENDMENT OF ARTICLES**

The corporation reserves the right to amend or repeal any provisions contained in these Articles of incorporation or any amendments to them, and any right conferred upon the members is subject to this reservation.

#### **ARTICLE THIRTEEN. INCORPORATORS**

We, the undersigned, being the incorporators of this corporation, and including all the persons herein named as the subscribers of this corporation, for the purpose of

forming this nonprofit charitable corporation under the Laws of Florida have executed these articles of incorporation on this 21 day of October, 2020.

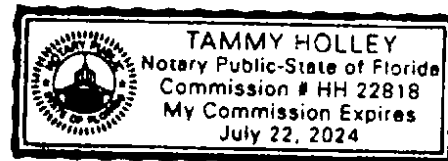
