## ARTICLE III PURPOSE

#### 3.01 Purpose

Smart Moves Academy, Inc. is a non-profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The purpose and vision of this corporation is to unlock every child's potential through the science of brain change and movement, in an active and inclusive school experience K12. Towards that end we may also provide professional development for educators and parents. We intend to achieve this mission through the opening of a school working directly with children and families, that is supported through fundraising.

#### 4.05 Restricted Activities

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

#### 4.06 Prohibited Activities

Notwithstanding any other provision of this document, the corporation shall not carry on any activities not permitted to be carried on (I) by any corporation exempt from federal income tax as an organization described by section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
