Article II. Terms of Existence This Corporation shall have perpetual Existence.

Article III. Purpose and Powers

Said Corporation is organized exclusively for charitable, religious, scientific, and educational purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code. To present a set of programs, projects, services, classes, seminars, and lectures pertaining to Veteran Women. To provide transitional housing facilitation with programs, projects and service to aide in their successful reentry into society. To provide medical and mental health screenings, fitness and agility, nutritious meals and snacks, life skills, finance and banking skills as well as employability skills, computer skills and usage while promoting and encouraging socialization, moral, spiritual, emotional stability.
