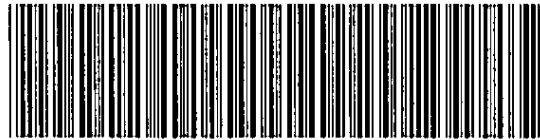

Article III: The general purpose for which this corporation is formed is to operate exclusively for such religious, charitable, and educational purposes as will qualify it as an exempt organization under section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that code. (This is an amendment to an existing article.)

Article IX: Upon dissolution of the corporation, the rest, residue, and remainder of the property of the corporation, whether personal or not, tangible or intangible, shall be deeded, liquidated, transferred, or given for exempt purposes to another Southern Baptist Church, the local Baptist Association, the Florida Baptist Convention, or another like-minded ministry organization. The Church Board shall select such beneficiary by a simple majority vote of the Church Board. (This is an additional article that does not currently exist.)

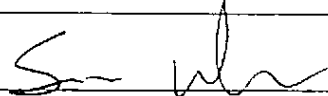
