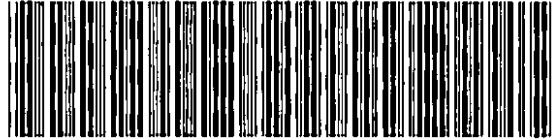

These articles may be amended only in the manner prescribed by statute.


#### **ARTICLE X. NOT FOR PROFIT CORPORATION**

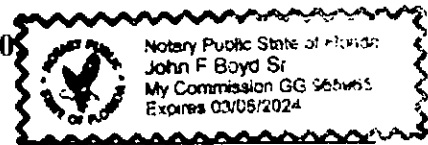


