Attachment to the Articles of Incorporation of Reach Dem Foundation Inc Article III Purpose

This corporation is established exclusively for charitable and religious purposes within the meaning of Section 501(c)(3) of the IRS Code, namely: to aid the poor, distressed, or underprivileged populations who are located in the State of Florida or elsewhere in the US and worldwide. Through the Gospel of Jesus, it will minister to the poor and downtrodden. providing spiritually uplifting positive transformations. Simultaneously, this corporation will strive to eradicate poverty and hunger. It will seek to bring about the improvement of health, the advancement of education and promotion of social justice. It will work with needy families or vulnerable individuals to prevent victimization and trauma. In particular it will struggle to save disadvantaged persons from becoming victims of human trafficking in all its forms. It will plan and implement supplementary education programs for children, youth and adults along with other activities aimed increasing the wellbeing of individuals, families, communities and children. In all its activities, it will strive to defend human and civil rights as secured by law, combat community deterioration and prevent juvenile delinquency.

In instances of crises --and at the sole discretion of the directors and the president-- this corporation is empowered to make direct cash grants to avert crises and prevent continued deterioration of families, individuals or children. This corporation is empowered to provide funding to other organizations when such organizations are better equipped to carry out some of the activities of this corporation. At such times the officers and directors will be responsible for verifying that the funds provided have been used to further the work of this corporation.

This corporation will conduct its activities in keeping with the letter and spirit of the IRS guidelines for a not for profit corporation. Its funds or assets will not inure to the benefit of its officers, directors or any private person unless it is given to pay for work done, services rendered or resources purchased in the advancement of its charitable and religious purposes. It will not attempt to influence legislation in any way or participate in political campaigns of any sort. In the event of the dissolution of this corporation, the directors will --after clearing all debts and liabilities-- distribute all remaining assets to other charitable corporations recognized as such by the IRS under section 501(c)(3) and that have similar goals.
