The following is placed at the end of article III: This corporation is founded exclusively for charitable religious

purposes within the meaning of the IRS Code Sec 501(c)(3); namely : To establish and maintain a House of Chabad

Chassidic Orthodox Jewish Worship and there to provide Jewish religious, educational, cultural, social and all other helpful

services according to Torah-Halachic tradition based on the Code of Jewish Law (Shulchan Aruch) by Shneur Zalman of

Liadi and other canonical texts of Orthodox Judaism. It will be empowered to pay salaries, as well as rent or buy personal

or real property, in order to provide a place of worship as well as a parsonage for the Rabbi Yakov Fellig and his family.

The Rabbi has been appointed according to Jewish Law. He is the incorporator, the spiritual leader and the final

authority in all matters pertaining to Ethics, Spirituality and Religious Law, including the sole authority to determine which

questions or issues are to be considered matters of Jewish Law and require his decision. This corporation will enhance

the Jewish presence in Miami by providing programs and events that promote Jewish education, inspiration and

practice. It will provide all spiritual and material needs to the growing community of young adults, business persons, families

seniors, and visitors. It will create a spiritual center where every Jew feels welcome to learn and experience his/her heritage

in a friendly atmosphere, with unconditional love and concern. This corporation shall not, except in an insubstantial

way, engage in any activities or exercise any powers that are not in furtherance of its charitable religious purposes. It will not

distribute dividends to any officer or director except that it will be empowered to pay reasonable compensation for services

rendered, expenses incurred and make purchases of goods or services that are in furtherance of its exempt purposes. It will

supply any resource which, in the eyes of the Rabbi, is required for the practice of Judaism, including but not limited to,

religious articles, kosher food, ritual immersion pools or transportation to any event or location. It will also seek to reach

out to the general community with the message of Judaism's universal path for all humanity and carry out activities to

bring the world closer to redemption.

In the event of the dissolution of this corporation, the directors will, after clearing all debts, distribute any remaining assets

to one or more charitable organizations recognized by the IRS under section 501(c)(3) that have similar exempt purposes.
