ARTICLES OF INCORPORATION

The undersigned President of RESPONSIBLE NEW MEDIA, INC., executes these Restatement of Articles of Incorporation of RESPONSIBLE NEW MEDIA, INC., pursuant to Chapter 617 of the Florida Statutes.

<u>ARTICLE 1 - NAME</u>

Notwithstanding any other provision of these Restatement of Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a

ARTICLE 4 - ADOPTION

ARTICLE 9 - TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE 16 - AMENDMENT
