## ARTICLES OF INCORPORATION OF History Makers International, Inc. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

#### **ARTICLE I NAME**

The name of the corporation shall be: History Makers International. Inc.
