

ARTICLES OF INCORPORATION OF THE THINKHER PROJECT INC.

The Articles of Incorporation for THE THINKHER PROJECT, INC. (hereinafter the "Corporation" or "The ThinkHer Project") are hereby filed filing pursuant to Fla. Stat. § 617.0202. The Articles of Incorporation are set forth and adopted by the as follows:

Article II: Principal Place of Business/Mailing Address. The principal place of business and mailing address of ThinkHer Project is 1219 North C Street, Lake Worth, FL 33460.

Article III: Purpose & Election of Not for Profit Corporate Status. The purpose of ThinkHer Project is to exist as a not for profit Corporation under Fla. Stat. § 617.0202; specifically, to create a material, positive effect on society and the environment, when taken as a whole, as assessed using a third-party standard which is attributable to the business and operations of the Corporation by promoting economic opportunity for women in third world countries, beyond the creation of jobs, in the normal course of business.

Article IV: The Directors of the Corporation shall be elected as set forth in the Bylaws.

Article V: The initial Directors of the Corporation are: Dawn De Celles, Greeny Valbuena, and Jennifer Paixao.
