PURPOSE

The corporation is organized and its assets shall be used solely and exclusively for charitable and educational purposes as defined by Section 501(c)(3) of the Internal Revenue Code of the United States, as amended (the "Code"). No part of the net earnings of the corporation shall insure to the benefit of or be distributable to any officers, directors or private individual, except that the corporation shall be empowered to pay reasonable compensation may be paid for services rendered and to make payments and distributions in furtherance of its exempt purposes. The corporation shall not (a) devote more than an insubstantial part of its activities to attempting to influence legislation, or (b) directly or indirectly participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE 4 DISSOLUTION

Upon the dissolution of the corporation, its remaining assets shall be distributed to an organization selected by the board of directors of the corporation that qualifies as a tax-exempt organization pursuant to Section 501(c)(3) of the Code. No officer, director or individual shall be entitled to share in any distribution of assets of the corporation upon its dissolution.
