ARTICLE III PURPOSE

- 1. Building Broken Bridges, Inc.'s mission is to focus on repairing broken relationships between families. While rebuilding broken communities and bridging the gap of communication between millennials and their elders. Bringing restoration through mentorship reaching and teaching at risk young ladies and gentlemen to understand their worth and develop them as leaders.
- 2. No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
- 3. The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX DISSOLUTION

- 1. The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof or to the benefit of any private person.
- 2. The manner of distribution of assets in this Corporation's winding up is as follows: Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or state or local government for public purpose. Any such asset not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purpose or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE X. LIABILITIES

The provision regarding liabilities for breach of duties is:

1. To the extent allowable by the laws of the State of Florida, no present or future Director of Building Broken Bridges, Inc., (or his or her estate, heirs and personal representatives) shall be liable to Building Broken Bridges, Inc. or its members for monetary damages for breach of fiduciary duty as a director of Building Broken Bridges, Inc.. Any liability of a director (or his or her estate, heirs, and personal representatives) shall be eliminated or limited to the fullest extent allowed by the laws of the State of Florida, as may hereafter be adopted or amended.

ARTICLE XI.

The provisions regarding indemnification of directors or officers are:

1. With respect to claims or liabilities arising out of service as a director or officer of Building Broken Bridges, Inc. shall indemnify and advance expenses to each present and future director and officer (and his or her estate, heirs and personal representatives) to the fullest extent allowable by the laws of the State of Florida, both as now in affect and as hereafter shall be adopted or amended.
