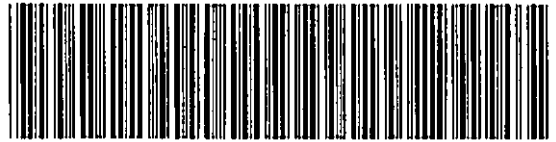



ARTICLES OF INCORPORATION

OF

INDIAN MOTORCYCLE RIDERS GROUP ORLANDO 2032, INC.

ARTICLE I - NAME

The name of this not-for-profit corporation is Indian Motorcycle Riders Group Orlando 2032, Inc.

ARTICLE II - DURATION

This not-for-profit corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation.
