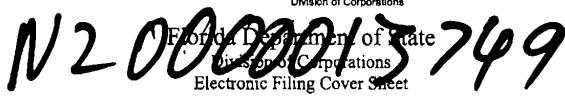

ARTICLES OF INCORPORATION

OF

RILEY BLAIR FOUNDATION, INC.

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is RILEY BLAIR FOUNDATION, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal address of the corporation shall be 4142 Mariner Boulevard, #230, Spring Hill, Florida 34609.

ARTICLE III: PURPOSE

This corporation is organized exclusively for charitable, religious, education and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue code, or corresponding section of any future federal tax code.

ARTICLE IV: QUALIFICATION

The qualifications for members and the manner of their admission are stated in the Bylaws of the corporation.

ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VI: INITIAL BOARD OF DIRECTORS

The effective date of filing is January 4, 2021.
