The undersigned, desiring to form a corporation under and pursuant to the laws of the State of Florida, for the purposes hereinafter stated, hereby make, subscribe and acknowledge and file with the Secretary of the State of Florida, these Article of Incorporation, as follows:

ARTICLE I - NAME

The name of the corporation shall be:

JABEZ COMMUNITY DEVELOPMENT CORPORATION

ARTICLE II - ADDRESS

The principal address of the corporation at the time of incorporation is:

1031 Ives Dairy Rd, Ste 228, Miami, Florida 33179

ARTICLE III - CORPORATE NATURE

This is a nonprofit corporation organized solely for general educational purposes pursuant to the Florida Statutes, Section 617, of the Florida Not For Profit Corporation Act.

ARTICLE IV - DURATION

The duration of this corporation is perpetual unless sooner dissolved according to law. Corporate existence shall commence on the filing of these articles by the Department of State.

ARTICLE V - GENERAL AND SPECIFIC PURPOSE

The specific and primary purpose for which this corporation is formed are:

(a) For the advancement of charity, education, religious, scientific, literary, and any other related or corresponding charitable purposes by the distribution of its fund for such purposes.

(b) The general nature and purposes of this corporation shall be exclusively charitable within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(c) To raise the economic, educational and social levels of the residents of Miami-Dade County, Florida, including members of the minority community, unemployed, underemployed, or low-moderate income residents, to foster and promote community wide interest and concern for the problems of said residents to the end that:

- (a) educational and economic opportunities may be expanded;
- (b) sickness, poverty, crime, and environmental degradation may be lessened; and
- (c) racial tensions, prejudice, and discrimination, economic, and otherwise, may be eliminated.
- (d) To expand the opportunities available to said residents and groups to own, manage, and operate business enterprises in economically depressed areas; to assist said residents and groups in developing entrepreneurial and management skills necessary for the successful operation of business enterprises.

(e) To assist residents, groups and businesses located (or to be located) in low-income communities by providing loans, equity investments or financial counseling.

(f) To expand opportunities available to said residents and groups to obtain adequate affordable housing accommodations by constructing, rehabilitating, and providing decent, safe and sanitary housing in South Florida for persons and families of low-income who otherwise would not be able to find or afford a suitable place to live. It is the purpose of the corporation thereby to relieve the poor, distressed, underprivileged and indigent by enabling them to secure the basic human needs of decent shelter and to thus lessen the burdens of government and promote social welfare. To provide such housing through rehabilitation of existing substandard buildings and construction of new facilities in the place of blighted vacant sites for the purpose of combating the deterioration of the community and contributing to its physical improvement

(g) The JABEZ COMMUNITY DEVELOPMENT CORPORATION admits students of any race, color, national or ethnic origin to all the rights privileges, programs, and activities generally accorded or made available to students at the school. It does not discriminate on the basis of race, color, national or ethnic origin in administration of its educational policies, admission policies, scholarship and loan programs, and other school administered programs.

ARTICLE VI - MANAGEMENT OF CORPORATE AFFAIRS

(a) Board of Directors. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of number not less than three (3) directors. The number of directors provided for in these Articles of Incorporation may be changed by a bylaw adopted by the board of directors.

(b) The Directors named herein as the first Board of Directors shall hold office until the first meeting of members at which time an election of Directors shall be held.

(c) Election of Directors. The method of electing directors shall be as set forth in the bylaws.

(d) Elective Officers. The officers of this corporation shall be a president, a vice-president, a secretary, and a treasurer. Other offices and officers may be established or appointed by the members of this corporation at any regular annual meeting or any special meeting of members called for such purpose. The qualifications, the time and manner of electing or appointing, the duties of, the terms of office, and the manner of removing officers shall be as set forth in the bylaws.

ARTICLE VII - EARNINGS AND ACTIVITIES OF CORPORATION

No part of the net earnings of the corporation shall insure to the benefit of, or be distributed to its members, directors, officers to other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article V hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) or the Internal Revenue Code of 1954 or corresponding provision of any future United States Internal Revenue Law).

Notwithstanding any other provision of these Articles, this corporation shall not, except to an insubstantial degree, engage in any activity or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE VIII - DISTRIBUTION OF ASSETS

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, education, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by a court of competent

jurisdiction in the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as such court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IX - QUALIFICATION AND ADMISSION OF MEMBERS

The qualification for members and the manner of their admission shall be regulated by the bylaws for this corporation.



ARTICLE XIII - AMENDMENT OF ARTICLES


