Please accept this letter as request and/or application for reinstatement of the Marine Archaeological Council, Inc. (MAC)

I, Daniel J. Shayler took over the responsibilities of Treasurer and Chairman of MAC on January 1, 2005. After receiving the box of records and receipts I realized that the corporation had not filed an annual report for 2004 or 2005. I was also informed by a phone call to the Division of Corporations that the 2003 report had been returned for corrections. I was told that the check for \$70.00 was still being held. I went back to the current and past board of directors and inquired as to the whereabouts or status of the 2003 report.
