#### AMENDED ARTICLES OF INCORPORATION OF IGLESIA CRISTIANA EL REBAÑO, INC.

1.

The name of the Corporation is Iglesia Cristiana El Rebaño, Inc.

2.

This corporation is organized pursuant to the provisions of the Florida Non-Profit Corporation Code.

3.

The corporation shall have perpetual existence.

4.

The mailing address of the current principal office of the corporation is 7339 E. Colonial Drive, Orlando, FL 32708.

5.

The name of the current registered agent is Carmen S. Hernandez and her address is 1125 Santa Cruz Way, Winter Springs, FL 32708.

6.

The corporation hereby elects to have no members.

Any action which would otherwise require a vote of members shall require only a Vote of the Officers/Elders, and no meeting or vote of members shall be required for this Corporation, any provisions of the Articles of Incorporation of this Corporation or the Bylaws to the contrary notwithstanding.

All rights which otherwise would vest in the members shall vest in the Officers/Elders.

7.

The corporation may engage in any lawful act or activity for which corporations may be organized under the Florida Non-profit Corporation Code.

R

The rules governing the management of the corporation shall be determined by the Bylaws of the corporation. The requirements for amending or restating these Articles shall also be determined by the terms of the Bylaws of this corporation.

9.

The purposes for which the corporation is organized are to receive and maintain real or Personal property, or both, and, subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable, religious, scientific, literary, or educational purposes either directly or by contributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, any Director, Officer, Elder, or member of the corporation, or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation, and reasonable expenses may be paid thereto, affecting one or more of the corporation's purposes), and no Director, Officer or Elder of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation. No substancial part of the activities of the corporation shall include the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall neither participate nor intervene (including the publication or distribution of statements) in any political campaign on behalf of any candidate for public office, at any time.

Upon the dissolution of the corporation, the Officers/Elders shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c) (3) of the Internal Revenue Code (or the corresponding provisions of any future United States Internal Revenue Law), as the Officers/Elders shall determine. Any of such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is than located, exclusively for such purposes or to such organization or organizations as the Court shall determine, which are organized and operated exclusively for such purposes.
