

# ARTICLES OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF MS-HHA II, INC.



(A Florida Not-for-Profit Corporation)

The undersigned for the purpose of amending the Amended and Restated Articles of Incorporation of MS-HHA II, INC., a Florida not-for-profit corporation (the "Corporation"), hereby certifies pursuant to Section 617.1007 of the Florida Not-For-Profit Corporation Act that:

- 1. The name of the Corporation is MS-HHA II, INC.
- 2. Article II of the Amended and Restated Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

### **ARTICLE II**

The Corporation is organized as a not-for-profit nonstock corporation to support Mount Sinai Medical Center of Florida, Inc. for the provision of the following:

- (a) To establish, operate, manage, and/or furnish home heath services for the care of persons suffering from illnesses and disabilities.
- (b) To provide quality home health patient care as an alternative to in-patient hospitalization and treatment and institutionalization.
- (c) To promote, provide, and/or otherwise obtain home health services for the sick or infirm, including those served by Medicare and other governmental health care programs, such home health service to include any and all related forms of medical and ancillary goods and services.
- (d) To conduct any and all lawful affairs and business for which corporations may be organized and operated under the Florida Not-For-Profit Corporation Act.

3. Article VI of the Amended and Restated Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

### ARTICLE VI

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to the Corporation's Directors, officers or private individuals, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered or expenses incurred and to make payments and distributions in furtherance of the purposes set forth in Article II hereof.

4. Article VII of the Amended and Restated Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

### ARTICLE VII

It is intended that this Corporation shall have the status of a corporation which is exempt from Federal income taxation under Section 501(a) of the Code as an organization described in Section 501(c)(3) of the Code, and which is other than a private foundation by reason of being described in Section 509(a)(3) of the Code. The Corporation supports Mount Sinai Medical Center of Florida, Inc., the supported organization, which is exempt within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986. These Articles shall be construed accordingly, and all powers and activities of the Corporation shall be limited accordingly. The Corporation shall not carry on propaganda or otherwise attempt to influence legislation to such extent as would result in loss of its exemption from Federal income tax under Section 501(c)(3) of the Code. Further, the Corporation shall not participate in or intervene in (including the publishing or distributing of statements) any political campaigns on behalf of or in opposition to any candidate for public office. The term of the Corporation shall be perpetual.

5. Article IX of the Amended and Restated Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

### ARTICLE IX

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any assets not so disposed of shall be disposed of by the Court of Common Pleas, of the county in which the principal office of the Corporation is then located, exclusively for such purposes.

5. The foregoing amendments were adopted by the sole Member of the Corporation by Written Consent dated as of Hay 27, 1998 and the number of votes cast for the foregoing amendments was sufficient for approval.
