ARTICLES OF INCORPORATION
OF
DATAW ISLAND CLUB, INC.

A FLORIDA NOT FOR PROFIT CORPORATION

FILED
MAY 15 1966
TALLAHASSEE, FLA.

THE UNDERSIGNED, in accordance with the provisions of 617.013, Florida Statutes, hereby makes, subscribes and acknowledges these Articles of Incorporation.

I

The name of the corporation is DATAW ISLAND CLUB, INC. (the "Club").

II

The term for which the Club is to exist is perpetual unless it is dissolved pursuant to any applicable provision of Florida Statutes. The Club shall commence to exist upon the filing of the Articles of Incorporation with the office of the Secretary of State, State of Florida.

III

The purpose for which the Club is organized as a non-profit corporation in accordance with the provisions of Chapter 617, Part I, Florida Statutes, is to acquire ownership or control of and operate and maintain golf courses, a clubhouse, and related recreational and social facilities.

IV

The members of the Club shall be such persons as are admitted to membership in accordance with procedures established in the Bylaws and by the Board of Directors of the Club. The membership shall be limited as set forth in the Bylaws. Membership rights shall be as stated in the Bylaws.

V

The Club shall have no capital stock, but shall issue a certificate of membership to the members and may require a capital contribution for the certificate of membership, as provided in the Bylaws.

VI

The Club is one which does not permit pecuniary gain or profit. No part of any net earnings of the Club shall inure to the benefit of any member, director or officer, and as such they will have no interest in or title to any of the property or assets of the Club. Nothing herein shall prohibit the Club from paying compensation in reasonable amounts to its directors, officers and managers for services rendered to the Club.

VII

The initial registered office of the Club shall be at 17290 Jonathan Drive, Jupiter, Florida 33477. The initial registered agent at such address is Richard W. Plowman.

VIII

The Club shall be governed by a Board of Directors consisting of not less than three (3) nor more than fifteen (15) persons. The initial Board of Directors shall consist of three (3) persons unless and until changed by resolution as provided in the Bylaws. In the event of dissolution or final liquidation of the Club, all of the property and assets of the Club, after payment of its debts, shall be distributed, as permitted by a court having jurisdiction in accordance with the terms of the Bylaws.

XI

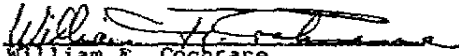
For so long as Alcoa South Carolina, Inc., its successors or assigns shall own the Class C Membership (as defined in the Bylaws), Alcoa South Carolina, Inc., its successors or assigns, as the owner of the Class C Membership may amend these Articles of Incorporation as it shall deem appropriate and no prior notice of such amendment shall be required. After the date Alcoa South Carolina, Inc., its successors or assigns no longer owns the Class C Membership, these Articles of Incorporation may be amended at any annual meeting of the members or at any special meeting thereof if notice of the proposed amendment to be made be contained in the notice of such special meeting, by the affirmative vote of a majority of the Class A and B Memberships entitled to vote thereat, or by the affirmative vote of a majority of the Board of Directors at any regular meeting of the board or at any special meeting of the board if notice of the proposed amendment to be made, be contained in the notice of such special meeting.

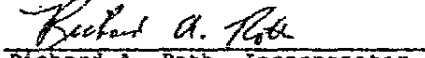
XII

The Club shall indemnify any and all persons who may serve or who have served at any time as directors or officers, and their respective heirs, administrators, successors and assigns against any and all expenses, including amounts paid upon judgments, counsel fees, and amounts paid in settlement (before or after suit is commenced), actually and necessarily incurred by such persons in connection with the defense or settlement of any claim, action suit or proceeding in which they or any of them are made parties, or a party, or which may be asserted against them or any of them, by reason of having been directors or officers or a director or officer of the Club, except in such cases wherein the director or officer is adjudged guilty of willful misfeasance or malfeasance in the performance of his duties. Such indemnification shall be in addition to any rights to which those indemnified may be entitled under any law, Bylaw, agreement, vote of members or otherwise.

XIII

Prior to the Turnover Date (as defined in the Bylaws), the Board of Directors and the individual directors thereof and the officers shall owe no fiduciary duty to any of the members of the Club and no cause of action shall lie against any or all of the directors or officers for breach of any duty owed to the Club or any of its members.

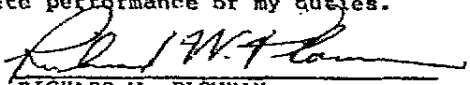

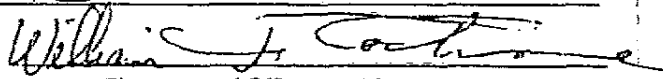
