**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION


Amendment

ARTICLE TWO: PURPOSE

This **religious corporation** is a church or church controlled organization authorized to transact business, no one may have it's name or same name, it can sue, borrow, file bankruptcy and more. This corporation is a nonprofit religious benefit corporation and is not organized for the private gain of any person. The corporation is organized under GOD in which we trust. In accordance to the 1st Amendment of the United States Constitution and GOD Divine Status (1 Corinthians 12:28). This Religious Benefit Corporation is part of the Church, which is the body of our Lord and Savior Jesus Christ to promote religious activities. This corporation is tax-exempt and can receive tax-deductible contribution as outline in IRS Publication 557 and Application 1023. This corporation is not required to file annually tax returns for church or religious related business. This religious corporation shall establish and carry out business related to but, not limited to: The Religious Creed; By-Laws; Standard Operational Procedures, Divine Doctrine and other related religious activities.

Therefore, a Vote was taken by the Board of Directors, with all three (3) directors in favor of and zero (0) against. The meeting was adjourned at 1:15 P.M.
