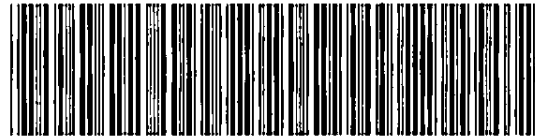

of The Keep Going Foundation Inc. to The Hassell Foundation Inc.




