Articles of Incorporation of

[Killer Mans Sons MC Fort Brooke Inc]

The Corporation is organized and shall be operated on a not-for-profit basis and exclusively as a voluntary employees' beneficiary within the meaning of Section 501 (c) (9) of the Internal Revenue Code (or the corresponding provisions of any future United States federal tax law). The purpose of this corporation is to provide payment of life. sick, accident, or other benefits to members or their dependents or designated beneficiaries. The specific purposes of this corporation are a Motorcycle Club comprised of active and retired Special Operations Veterans supporting Special Operations Forces (SOF) military service members (Past and Present), and family members of perished SOF military service members.

This corporation is a nonprofit MUTUAL BENEFIT CORPORATION organized under the Nonprofit Mutual Benefit Corporation Law. The purpose of this corporation is to engage in any lawful act or activity, other than credit union business, for which a corporation may be organized under such law.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf on any candidate for public office.

The property of this corporation is irrevocably dedicated to charitable and voluntary employee beneficiary purposes and no part of the net income of assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Furthermore, the net earnings of this corporation shall be devoted exclusively to mutual benefit purposes. Upon dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for such purposes stated above and which has established its tax exempt status under Section 501(c)(9), Internal Revenue Code.
