

ARTICLES OF INCORPORATION

Articles of Incorporation of Storer Alumni Foundation, Inc.

The undersigned, a citizen of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, and desiring to form a 501(c)(3) Non-Profit Corporation under the Internal Revenue Code of the United States of America, does hereby certify:

ARTICLE 1: The Corporation

The name of the Corporation shall be "Storer Alumni Foundation Inc"

ARTICLE 2: The Address

The principle address of Storer Alumni Foundation Inc shall be 8315 Old Forest Road, Palm Beach Gardens, FL 33410 (Palm Beach County).

ARTICLE 3: The Purpose

Storer Alumni Foundation Inc is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Storer Alumni Foundation Inc is created to enhance and perpetuate youth development programs for children in the New England area (Maine, New Hampshire, Vermont, Massachusetts, Connecticut and Rhode Island). Storer Alumni Foundation Inc will assist camps and reservations in New England that promote:

- Personal fitness through outdoor sports (Swimming, Hiking & Boating)
- Environmental Education through Forestry, Conservation and Geology exposure and studies
- Citizenry Education through Native American and Colonial American exposure and studies
- Self-sufficiency by acquiring first aid, camping and cooking skills
- Comradery and teamwork through group activities

To achieve this, Storer Alumni Foundation Inc shall provide supplemental financial support for:

- Restoration of current physical structures and activity centers (design and construction)
- Creation of new activity facilities and activity centers (design and construction)
- Equipment needed to properly operate activity/program areas
- Scholarships for youth unable to afford the opportunity to participate in said activities
- 501(c)3 organizations whose purpose aligns with those of the Storer Alumni Foundation

No part of the net earnings of Storer Alumni Foundation Inc shall inure to the benefit of, or be distributed to its members, trustees, officers or other private persons, except that Storer Alumni Foundation Inc shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article 3. No substantial part of the activities of Storer Alumni Foundation Inc shall be the carrying on of propaganda, or otherwise attempting to influence legislation and Storer Alumni Foundation Inc shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, Storer Alumni Foundation Inc shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Storer Alumni Foundation Inc shall use its funds only to accomplish the stated purposes in Article 3 of these Articles of Incorporation.

Upon the dissolution of Storer Alumni Foundation Inc, the assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of Storer Alumni Foundation Inc is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE 4: Board of Directors

The initial Board of Directors (Principal Members) is established by the original Articles of Incorporation. The Board of Directors shall maintain an initial term of three years. The Board shall be comprised of a minimum of five members and a maximum of seven members. Board Members shall serve until their term expires or resign, whichever occurs first. Board replacements shall be presented to the board by an ad hoc nominating committee. Replacements require a majority vote of the Board. Board members may serve consecutive terms.

ARTICLE 5: The Initial Directors


