### Article III

Said corporation is organized exclusively for religious, charitable and educational purposes, including, a synagogue for religious services and community outreach and for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The corporation shall further be permitted to engage in any lawful act for which corporations may be organized under the Florida Non-Profit Corporation Act. Notwithstanding any other provisions of these articles, the corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code of 1986, and shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under IRC 501(c)(3) or corresponding provisions of any subsequent law.

### Article VIII

No part of the net earnings of the corporation shall inure to the benefit of, or be distributive to, its members, trustees, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation. In any year in which the corporation is a private foundation as described in Section 509(a), the corporation shall distribute its income for said period in such time and manner as not to subject it to tax under IRC 4942, and the corporation shall not engage in any act of self-dealing as defined in IRC 4941(d), retain an excess business holdings as defined in Section 4943(c), make any Investments in such manner as to subject the corporation to tax under Section 4944, or make any taxable expenditures as defined in IRC 4945(d) or corresponding provisions of any subsequent federal tax laws.

### Article IX

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to the state of local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
