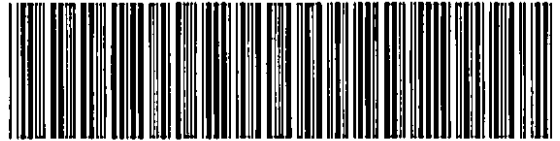

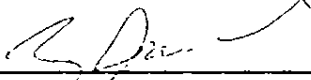
Article 7 **Officers**

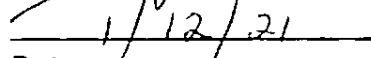
