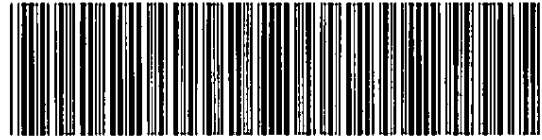

**Article I - Name of Corporation**

**Article III – Purpose**

The specific purpose for which the corporation is organized is:

To use any and all types of media, i.e., conferences, retreats, internet website, video, guest speakers, to accomplish this purpose.
