The undersigned subscriber to these Amended Articles of Incorporation, desiring to form a Not-For-Profit Corporation under the laws of the State of Florida, do hereby accept all of the rights and privileges, benefits and obligations conferred and imposed by said laws and hereby adopt the following Articles of Incorporation as the Charter of the Corporation hereby organized.

Article I. Corporate Name

The Name(s) of this Corporation shall be:

Senior Transitional Assistance Community Development, Corp.

Article II. Terms of Existence

This Corporation shall have perpetual Existence.

Article III. Purpose and Powers

Said Corporation is organized exclusively for charitable, religious, scientific, and educational purposes, including r such purposes the making of distributions to organizations that qualify as exempt organizations under section 501 (c) of the Internal Revenue Code or corresponding section of any future Federal tax code. To provide assistive services to r service community for those in need. To assist seniors to appy and recertify for food stamps. To provide Senior rusing Locations and Assistance. To provide supplemental food distribution and other essentials. To eventually wide senior day care and other senior benefits. To network with other CDCs, Faith based and governmental agencies.

No part of the of the net earnings of the Corporation shall inure to the benefit of, or be distributed to its members, stees, directors, officers and other private persons, except that the corporation shall be authorized and empowered to reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 (3) purposes. No substantial part of the activities of the Corporation shall be in carrying on of propaganda, or otherwise impting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or ribution of statements) any political campaign on behalf of, or in opposition to any candidate for public office.

Notwithstanding any other provision of the Articles, the Corporation shall not carryon any other activities not nitted to be carried on by a corporation exempt from Federal Income Tax under Section 501 (c)(3) of the Internal enue Code, or corresponding section of any further Federal tax code.

Upon dissolution of this Corporation, assets shall be distributed for one or more exempt purposes with the ning of Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any further Federal tax code, or I be distributed to the Federal Government, or to a state or local government, for a public purpose.

Article IV. Capital Stock

There will be no capital stock in this corporation.

Article V. Initial Capital

The initial capital with which this corporation may be in business shall have any shares.

Article VI. Directors
