



Article III of the Articles of Incorporation is deleted in its entirety and will be replaced with the following language:

The specific purpose of the Corporation is to help youth (middle and high school ages) who suffer from the effects of marginalization and bullying. The Corporation acknowledges that bullying can have a devastating mental and emotional impact upon a young person's life. Accordingly, the Corporation will, mainly through the performing arts, lift up the lives of bullied youth by bringing their stories to life and seeking to awaken hope in their lives. The Corporation will further seek to combat bullying and its damaging impact on fragile youth by inspiring change in the culture of our schools and communities.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
