#### **ARTICLE I**

#### 7 BY 70 INCORPORATED

#### 1.01 Name

The legal name of his corporation shall be 7 by 70 Incorporated. The business if the corporation will be conducted as 7 by 70 Incorporated.

#### **ARTICLE II**

#### **DURATION**

2.01 Duration

The period of the corporation shall be perpetual.

#### **ARTICLE III**

#### **PURPOSE**

#### 3.01 Purpose

7 By 70 Incorporated is a non- profit corporation organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations, under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Our mission is transforming lives of the recently incarcerated and their families, by dropping titles, finding love, finding purpose, creating new beginnings, and understanding the meaning of true forgiveness.

To maximize our effectiveness, we may seek to collaborate with other non- profit organizations which qualify as non- profit corporations under section 501 (c)(3).

3.02 Public Benefit

7 by 70 incorporated is designated as a public benefit corporation.

#### **ARTICLE IV**

NON- PROFIT NATURE/ BENEFITS

#### 4.01 Non-Profit Nature

7 by 70 incorporated is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its charitable, religious, educational or scientific purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to, any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these articles.

#### 4.02 Personal Liability

No officer of director of this corporation shall be personally liable for the debts or obligations of 7 by 70 incorporated of any nature whatsoever. Nor shall any of the property or assets of the officers or directors be subject to the payment of he debts or obligations of this corporation.

#### 4.03 Dissolution

Upon termination or dissolution of 7 by 70 incorporated, any assets lawfully available for distribution shall be distributed to one or more qualifying organizations described in Section 501 (c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statue), which organization or organizations shall have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

The organization to receive the assets of 7 by 70 incorporated hereunder shall be selected by the discretion of a majority of the managing body of the 7 by 70 incorporated and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity field in a court of proper jurisdiction against 7 by 70 incorporated by one or more of its managing body, which verified petition shall contain such statements as

reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose which, at least generally, includes a purpose similar to this corporation, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida, or its equivalent, to be added to the general fund.

#### 4.04 Prohibited Distributions

No part of the net earnings, or properties of this corporation, on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, directors, officers or other private person or individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III, Section 3.01.

#### 4.05 Restricted Activities

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

#### 4.06 Prohibited Activities

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax as an organization described by Section 501 9(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions o which are deductible under Section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE V**

**BOARD OF DIRECTORS** 

5.01 Governance

7 by 70 Incorporated shall be governed by its board of directors.
