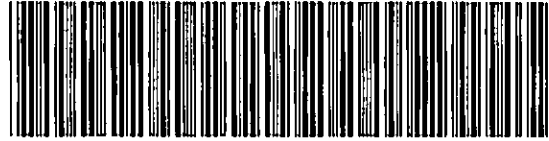

NONPROFIT ARTICLES OF INCORPORATION

These Articles of Incorporation of a Nonprofit Corporation are submitted for filing for the purpose of creating and incorporating a nonprofit corporation pursuant to the applicable provisions of laws of the State of Florida and Florida Statute Chapter 617.

ARTICLE I CORPORATE NAME

The name of the nonprofit is C & C Pet Fund, Inc. (the "Corporation").

ARTICLE II DURATION

The period of duration of the Corporation is perpetual.

ARTICLE III PURPOSE

The Corporation is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The specific purpose of this Corporation is to help fund veterinary services for pet owners that are unable to financially support their personal pets. Our mission is to provide the resources to low-income households for preventative care, diagnostic testing, treatment, hospitalization, and life-saving surgeries. The Corporation will also help fund treatment and care for animals who are homeless (good samaritan cases). The Corporation endeavors to help save animals and prevent avoidable euthanasia. The Corporation's guiding principal is to protect and advocate for companion animals in need, and in doing so, help maintain the human-animal bond.

ARTICLE IV BUSINESS ADDRESSES

ARTICLE V SERVICE OF PROCESS

ARTICLE VI MEMBERS

The Corporation shall not have members. The management of the affairs of the Corporation shall be vested in a board of directors, as defined in the Corporation's Bylaws.

ARTICLE VII ADDITIONAL STATEMENTS

The following language relates to the Corporation's tax exempt status and is not a statement of purposes and powers. Consequently, this language does not expand or alter the Corporation's purposes or powers set forth in Article III hereof:

(a) This Corporation is organized and operated exclusively for the purposes set forth in Article III hereof within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) The property of this Corporation is irrevocably dedicated to the purposes in Article III hereof and no part of the net income or assets of this Corporation shall ever inure to the benefit of any director, officer, or member thereof or to the benefit of any private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

(c) No substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and this Corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

(d) Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on:

(i) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code; or

(ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX DISSOLUTION

Upon the dissolution or winding up of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this Corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, and/or religious purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.
