Additional Attachment to: ARTICLE III PURPOSE

On behalf of a candidate for public influence legislation and this corporation shall not participate or intervene in political campaign office. Notwithstanding any other provision these articles, the corporation shell not carry on any other activities not permitted to be carred on (a) by a corporation exempt from federal income tax under 501 C (3) of the Internal Revenue Code (or corresponding section of i.e. charitable, educational, religionus or scientific, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or a local government for a purpose.

However if named is not then in existence or no longer a qualified distribute, or unwilling or unable to accept the distribution then the assets of the corporation shall be distributed to a fund, foundation or corporation organized and operated exclusively for the purposes specified in section 501 (C) 3 of the Internal Revenue Code (or corresponding section of any future Federal tax code.)
