Articles of Incorporation Of

(In Compliance with Chapter 617, F.S., Not for Profit)

Article 1.

The name of the corporation is Esperanza Group Foundation. Inc.

Article 2.

The initial registered office of the Corporation shall be at: 13301 SW 132 Ave STE 212. Miami, Florida 33186. The initial registered agent of the Corporation at such address shall be: Yurinia Avila.

Article 3.

The name and address of the incorporator is: Yurinia Avila, 13301 SW 132 Ave STE 212. Miami, Florida 33186.

Article 4.

The initial principal office address of the Corporation shall be at: 13301 SW 132 Ave STE 212, Miami, Florida 33186.

Article 5.

Specific Purpose: To distribute and donate food and other necessities to the elderly. children, and low income individuals.

Article 6.

The Corporation shall have perpetual duration.

Article 7.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
