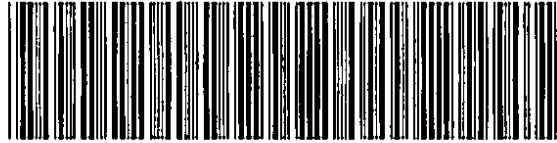

**ARTICLES OF INCORPORATION
OF
NORTH TAMPA BAY CHAMBER FOUNDATION, INC.**

The undersigned incorporator to these articles of incorporation hereby forms a not for profit corporation (the "Corporation") under the laws of the State of Florida as follows:

ARTICLE I

Name

The name of the corporation is North Tampa Bay Chamber Foundation, Inc.

ARTICLE II

Initial Principal Office and Mailing Address

The corporation's initial principal office and mailing address is 7868 Highland Oaks Blvd. Suite A, Lutz, FL 33559.

ARTICLE III

Purpose

The specific purpose of the corporation is to advance the educational, sociological, economic and cultural interests of the community served by the Greater Tampa Bay Chamber of Commerce, Inc.

This corporation is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organization that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV

Directors

The number of directors, and method of selecting directors, shall be fixed by the Bylaws of the corporation.

ARTICLE V

Initial Registered Agent and Office

The street address of its initial registered office is 2244 Green Hedges Way, Suite 101, Wesley Chapel, FL 33544 and the name of its initial registered agent at that address is Dineen Pashoukos Wasylik, P.A.

ARTICLE VI

ARTICLE VII
Duration

The corporation shall have perpetual existence.

ARTICLE VIII
Additional Provisions

8.1 No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III.

8.2 No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

8.3 No officer or director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers, or directors be subject to the payment of the debts or obligations of this corporation.

8.4 Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX
Dissolution

Upon the dissolution of the corporation, after paying or adequately providing for the debts, obligations, and liabilities of the corporation, the remaining assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


