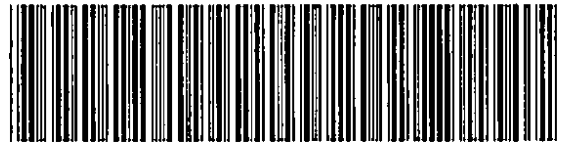

**ARTICLES OF INCORPORATION**  
**OF**

(A Florida Not-For-Profit)

**Article I. Name**

The name of the corporation shall be: REAL Ministries Worldwide, Inc.

**Article II. Principal Office**

The initial principal place of business and mailing address of the Corporation shall be:

**Article III. Purpose**

The specific purpose for which the corporation is organized is as follows:

Our purpose is to establish and oversee places of worship, teach, and preach, the gospel to all people, conduct evangelistic and humanitarian outreach, license, and ordain ministers of gospel and to also engage in purpose, or which are necessary, suitable, or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith which are consistent with Section 501(c)(3) of the Internal Revenue Code.

This corporation is organized exclusively for religious purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

This corporation will not attempt to influence legislation as a substantial part of its activities and will not participate at all in campaign for or against political candidates.

In addition, none of the earnings of the corporation will inure to any private shareholder or individual, except for reasonable compensation for services rendered.

If the corporation dissolves, its assets must be distributed for an exempt purpose within the meaning of Section 501(c)(3) of the Internal Revenue Code.

#### **Article IV. Management**

The Corporation's affairs shall be managed in accordance with the Corporation's bylaws. The number of directors may be increased or decreased in accordance with the Corporation's bylaws but shall never be less than the minimum required by law.

#### **Article V. Manner of Election**

The manner in which the directors are elected or appointed is as provided for in the bylaws.

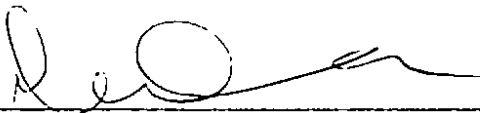
