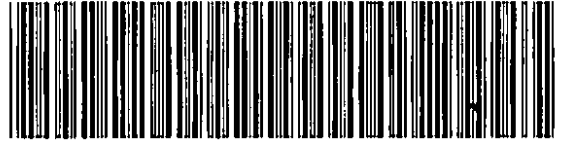

# ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

## **ARTICLE I: NAME**

The name of the corporation shall be: Friends of 7 Rivers Outreach, Inc.

## **ARTICLE II: PRINCIPAL OFFICE**

The principal office of the corporation is 245 Isle Verde Way, Palm Beach Gardens, FL 33418-1711. The mailing address of the corporation is the same.

## **ARTICLE III: PURPOSE**

The purpose for which the corporation is organized is exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation exists especially for the purpose of raising awareness and funding and volunteers for the benefit of 7 Rivers Outreach, a non-profit community outreach corporation existing under the laws of South Africa to glorify God through the gospel-driven transformation of rural South African communities south of Durban through Christian discipleship and spiritual community formation, through community, educational, health, and leadership development, through job skills and entrepreneurial training, and through foster care of orphans and vulnerable children.
