# ARTICLES OF INCORPORATION

For

We, the undersigned natural persons of the age of eighteen (18) years or more, at least two (2) of whom are citizens of the State of Florida, acting as Incorporators of a corporation under the Florida Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

### ARTICLE I

The name of the corporation is We Live, Incorporated.

### ARTICLE II

The organization is a charitable organization and is not organized for private gain of any person. The principal address of this organization is: 1001 Mayport Road, Suite 3305, Jacksonville, Florida 32233.

### ARTICLE III

The specific purpose of this Corporation is to serve as a catalyst to enhance the personal, physical and social development of individuals to prepare them to make decisions about, and making investments in the revitalization of their community, to build opportunity for individuals inclusive of youth to prosper. 
